NOTICE TO BIDDERS

Sealed bids will be received at the office of the Colfax County Clerk until May 14, 2024 at 10:30 a.m. and opened shortly thereafter, for the construction of a channel bank stabilization and riprap project. The project is located along Shell Creek, south of road D between Road 15 and Road 16 in Colfax County, Nebraska.

The project is referred to as “Shell Creek 2024 Bank Stabilization” and shall include all labor, materials, transportation, and equipment required to channel shape two areas of the Shell Creek north and south stream bank, tree root ball placement, rock riprap, and related incidental work.

Copies of the Bid Documents and Specifications are open to public inspection at the office of the Colfax County Clerk, County Courthouse, 411 E 11th St, Schuyler, Nebraska 68661. All Bid Proposals must be submitted on the forms furnished with the Bid Documents.

The sealed bids may be mailed or delivered to the County Clerk of Colfax County, Colfax County Courthouse, 411 E 11th St, Schuyler, Nebraska 68661 and should be plainly marked as, “Construction Bid Proposal – Shell Creek 2024 Bank Stabilization”.

Along with its Bid Proposal, each bidder shall submit an unconditional Bid Bond or Certified Check made payable to the County Treasurer of Colfax County, Nebraska, in an amount equal to five (5) percent of the Bid Proposal. Also, each bidder is to include an estimated delivery date with its Bid Proposal. The desired completion date is September 1, 2024. The successful bidder (i.e. Contractor) will be allowed thirty (30) calendar days for completion, after beginning work at the site.

Within ten (10) days following the award of the Contract, the successful bidder shall furnish a surety bond or bonds in an amount equal to or greater than the full amount of the contract. The surety and form of the bonds are subject to acceptance by the Colfax County Board of Commissioners.

The Colfax County Board of Commissioners reserves the right to reject any and all bids or to waive any irregularities in bids received. Award of the Contract will be in accordance with the County Purchasing Act’s competitive bidding considerations as set forth in Neb.Rev.Stat. §§ 23-3110 to 23-3114.
